## ORDER

Shri. Rajendra Uttamrao Patil, the applicant had preferred an initial application dtd. 20.1.2009, before the Public Information Officer, Maharashtra Pollution Control Board, asking information about the List of Seniority of Field Officer placed before Departmental Promotion Committee held on 12.12.2008, List of Departmental Promotion Committee Members, Minutes of the meeting held on 12.12.2008 of Departmental Promotion Committee, Copies of the validity caste certificates of selected candidates of reserve Category, copies of the office orders of promotions issued on 19.1.2009 for the post of Sub-Regional Officer, attendance of the Committee Members, Board resolution of approval given for Constitution of Departmental Promotion Committee for 'A' Grade Cadre and copy of the delegation of powers given by the Board for Appointment of 'A' Grade officers.

The Public Information Officer called information from the Establishment Department vide letters dtd. 30.1.2009, 4/2/2009 & 03/03/2009 respectively, but he had not received any information from the Establishment Department within the stipulated time.

- During the Course of hearing Sr. Administrative Officer has made available Minutes of DPC dtd. 12.12. 2008 and i.e. acceptable.
- 4) Though, the Caste Validity Certificate in respect of a) Rajput Raju Asaram b) Amar Durgule c) Shree Raju Vasawe have been received in the said information, the Caste Validity Certificates of i) Shri. M.R. Lad ii) Shri. Nagesh Shantaram Lohalkar iii) Shri. Shankar Waghmare iv) Shri. Vijay Narayan Patil v) Shri. A.M. Kare and vi) Shri. Sayed are not made available.to him.
- Sr. Administrative Officer informed that the caste validity G.R. has been made applicable recently and therefore, the request of the applicant to make available copies of the caste validity certificates in respect of the other candidates, who have not been selected or promotion from the General Category, but, at the time of their appointment they were in Reserve Category. Caste validity Certificates are not available but, **their caste certificates are available with the Board, Copies of which will be made available within 15 days time.**
- 5) Copies of the Officer Orders of promotions in respect of the above Field Officers issued on 19.1.2009 has been made available to the Appellant and that is acceptable.
- 6) Attendance of the Departmental Promotion Committee members is available in Minutes of Demartmental Promotion Committee held on 12.12.08, which are made available to the appellant by the Sr. Administrative officer during the course of personal hearing.
- 7) A copy of the resolution passed by the Board for delegating powers for Departmental Promotion Committee to consider promotions to the Cadre 'A' is made available to the Appellant.
