Sub: (i) Supply of pre-mixed 2T oil for two and three wheelers in Solapur Municipal area.
(ii) Banning sale of loose 2T oil .

Ref: Review Meeting held by EPCA at Solapur on January 9, 2005 in the Supreme Court of India in the matter of W.P.(Civil) 13029 of 1985.

WHEREAS, the Environment Pollution Control Authority appointed by Hon'ble Supreme Court of India is entrusted with the compliance in respect of the directives that are given by the Apex Court to control air pollution in some of the cities in India;

AND WHEREAS, an Action Plan has been prepared for the control of air pollution in Solapur Municipal Corporation area, in the State of Maharashtra;

AND WHEREAS, the issue on the supply of pre-mixed 2T oil for two and three wheelers in the Solapur Municipal area came up for discussion during the review meeting of Environment Pollution Control Authority on 9.01.2005.

AND WHEREAS, the Environment Pollution Control Authority directed that from April 1, 2005 onwards Municipal Area of Solapur shall be supplied only with pre-mixed 2T oil for two and three wheelers and supply of loose 2T oil shall be banned in Solapur.

AND WHEREAS, the Environment Pollution Control Authority directed that directives be issued by MPCB in this regard to the oil companies who are supplying fuel in Solapur municipal area.

NOW, THEREFORE, as directed by the Environment Pollution Control Authority, you are hereby directed to ensure supply of pre-mixed 2T oil for two and three wheelers in Solapur Municipal Corporation area with effect from April 1, 2005 and stop sale of loose 2T oil.

The action taken report in this regard shall be sent to Environment Pollution Control Authority under intimation to Maharashtra Pollution Control Board.
