In pursuance of the order dated 11<sup>th</sup> August, 2006, Respondent No.6 has filed Affidavit dated 23/8/2006 stating therein that in view of the grievance of the petitioners, Respondent No.6 has removed loud speakers on 13/8/2006. Respondent No.6 further states that no loud speakers or public address system is presently deployed either on the terrace or at any other place on the outer wall of the Gurudwara. Alongwith affidavit, Respondent No.6 filed copy of the letter issued by the Additional Dist. Magistrate, Chandrapur dated 27/07/2006. On perusal of the said letter, it appears that as the matter is pending before this court, the competent Authority could not take any decision on the application made by the Respondent No.6. Learned Counsel for Respondent No.6 submits that Respondent No.6 will not install loudspeakers even on any special occasion without prior permission of the competent Authority.

In view of the Affidavit filed by Respondent No.6 and the statement made before the court, the grievance of the petitioners is redressed. Nothing survives in the petition. The competent Authority to take decision in the matter in accordance with law. The petition is disposed off.
