Industry shall submit the BG of Rs. 5 lakh towards compliance of consent to establish conditions. It was also decided not to consider the request of the industry to charge the consent fee on 4.89 Cr which is increase over gross block except land cost whereas, Rs. 24.26 Cr was land value which is appreciated from 0.1 Cr to 24.26 Cr during 2016-17. Consent shall be issued after submission of additional requisite consent fee.
