Thereafter, CAC discussed on following points;

1. Chairman has reviewed the action taken report of the cases approved during CAC dtd. 21.09.2011 to 09.11.2011 and it was found that many cases are pending due to non receipt the balanced consent fees as per revised consent fee circular dtd. 25.08.2011. Hence, it was decided to call the explanation from respective HOD for not initiating further action in respect of cases mentioned in said follow-up action at Sr. No. (1), (3), (5), (6), (7), (8), (25), (27), (28), (35), (36), (37).
2. The circular issued by the Board on ....regarding collection of revised consent fees as per GoM letter dtd. 25.08.2011, wherein it was instructed that all CAC/CC applications shall be routed through CAO was discussed in detail. To avoid further delay in processing the application, it was decided that CAO should prepare the checklist for collection of consent fees and circulate the same to all HOD in two days. The HOD's can refer the application to CAO in case of any doubt. It was not necessary to refer each case to CAO.

The meeting ended with vote of thanks to the Chair.
