The consents shall be disposed after obtaining necessary consent fee difference from the industry as per GoM, Revised Consent fee structure dtd. 25.08.2011.

Thereafter, CAC discussed on following points;

1. CAC decided that the reference of MoEF circular in respect of “not to take any effective step before obtaining Environmental Clearance” shall be made in the Consent of Construction Project. A Circular shall be issued in this respect.
2. Agenda on Classification of Industries shall be placed in Board meeting.
3. The industries who are utilizing treated effluent (more than 100 CMD) on land for gardening/irrigation purpose, they shall carry out ground water sampling twice in a year.
4. CAC discussed on utilization of common ETP by sugar and co-generation plant and hence, decided to amalgamate the consents of sugar & Co-generation plant. A Circular in this respect shall be issued by JD(WPC).
5. CAC taken the review of water Cess paid by industries and it was found that many industries have not received Cess Assessment Order. Hence, details Cess Assessment done, Returns filed and Cess paid shall be placed before next CAC by CAO.
6. Regional Officer’s should monitor the compliance of directions issued by the Board, capital investment increased, submission of Environmental Statement strictly.
7. JD(WPC) shall prepare a note on generation of liquid waste management in Distillery plants & regime for future and place before next CAC.
8. It was decided that next CAC meeting will be scheduled on 14th December, 2011.

The meeting ended with vote of thanks to the Chair.
