The meeting ended with vote of thanks to the Chair.

General Point:

1. CAC deliberated on the issue of category of industry/activity having DG set more than 5 MVA capacity in Red category as per the revised industry categorization of industry and it was decided that in such cases consent shall be considered / issued in RED category henceforth.
