The consents shall be disposed after obtaining necessary consent fee difference from the industry as per GoM, Revised Consent fee structure dtd. 25.08.2011.

Thereafter, CAC discussed on following points;

- 1. RO/SRO's shall submit point-wise compliance of Consent to Establish along with application for grant of consent to 1st operate.
- CAC discussed the Auto Renewal for plain renewal consent application process in detail and it was decided in principle to implement the same immediately. JD(PAMS) prepare a detailed note for the same.
- 3. HOD's will carryout sectorial study of industries w.r.t. pollution problems and strategies to be adopted, time frame for compliance, etc. JD(PAMS) will prepare on Bulk-drug and Dyes, JD(APC)- Power plant and sponge Iron plant, JD(WPC)- Sugar and Distillery plants, RO(HQ)-Real Estates, AS(T)-Hotel industry.
- 4. It was decided that RO(HQ) will put up a note on MSW Authorizations.
- 5. A session on CETP will be conducted on mid-of-February, 2012. JD(WPC) shall prepare a discussion note bringing out the status of CETPS's in the State.
- 6. HOD shall take follow-up that all applications received at RO/SRO's shall reach at HQ by 17th Jan, 2012.
- 7. HOD's shall prepare a note on review of cases to whom consent to establish have been granted by the Board and will submit status report to CAC on 23rd Jan, 2012.
