- 1. All RO/SRO were directed through E-mail dtd. 16.01.2012 to forward all CAC applications pending at their offices to HQ on or before 18.01.2012 by Special Messenger. However, in-spite of several reminders, they have not sent the said applications to HQ. Hence, it was decided to call explanation from RO/SRO to why they have not sent the same to HQ.
- 2. CAC brought to the notice that HOD/RO's are issuing directions to the industry who do not have valid consents, the validity of which has expired or are not valid for other reasons. Therefore, it was decided that no directions/SCN/hearings shall be issued to the industry who do not have valid consent without explicit approval of CAC. A circular in this respect shall be put up by Sr. L.O.

ANNEXURE

M/s. Hitech Carbon, MIDC Patalganag, Dist. Raigad

Industry has submitted distance certificate from Executive Engineer, Kolad, Dist. Raigad dated 17.11.2011 wherein distance of 3.01 km from river Patalanga is mentioned. However, the plots referred in consent application of distance certificate are not matching. It was also mentioned that there is a habitation @ 400m from industry and it is necessary to stipulate suitable condition in view of Chlorine storage though it is covered by DISH separately. There is major water intake works just downstream of industry. Considering all the above, CAC decided to grant condition with following conditions:

- 1) The entire effluent shall be reused and recycled in the process. The treated effluent shall not be used for plantation / gardening etc.
- 2) Industry shall provide adequate effluent collection and minimum one day storage facility for any emergency condition, resulting into discharge of effluent. Under no circumstances, effluent shall be discharged outside premises.
- Industry shall provide three ambient air quality station including chlorine as special parameter with necessary alarm system.
- 4) Industry shall prepare online and offside disaster management plan and get it approved from the Competent Authorities.
