The Consent Appraisal Committee meeting of the Board held on 14.02.2012. Following members of the Consent Appraisal Committee were present:

The consents shall be disposed after obtaining necessary consent fee difference from the industry as per GoM, Revised Consent fee structure dtd. 25.08.2011.

Further, CAC discussed on following points;

1. Board is issuing consent to Establish for the period upto Commissioning of the unit. The industries are applying for grant of permission for Trial Run before C to O claiming that there is no commercial production. Hence, Board is granting permission for Trial Run to check process equipments/ pollution control system for 3 months/six months period depending on the process and size of unit. However, it is found that during this Trial Run period, some industries are taking commercial production. Therefore, CAC decided to issue a detailed circular that the C to E includes commissioning of equipments and processes without commercial production. Industry Board needs to undertake that this commissioning including trial run will not be for commercial production/activities. All the pollution control norms shall be strictly adhered to the industry at this stage. Industry shall inform of their commissioning plan at-least 15 days in advance to concerned RO/SRO along with industry Board Resolution as mentioned above. The practice of issuing Trial Commissioning shall be discontinued forthwith.

- 2. CAC discussed on Legal Matrix on Non-compliance and approved it in-principle. It was decided that said legal matrix shall be circulated to all RO/SRO and ask them to inventories the directions in-force for CAC industries in their area, in this Legal Matrix. They can also identify specific directions which can not be defined/categorized in this matrix. RO/SRO shall further review compliance of all CAC industries where consent renewal is due till July, 2012 and proposed the specific directions as per the matrix to coordinating HOD in next 8 days. If anything remained after this gap analysis, RO/SRO will be responsible for it. All directions shall be issued before 31st March, 2012.
- CAC found that there is need to study the Environmental Statements submitted by the industry and its co-relation to the compliance of consent conditions. Hence, it was decided that one Field Officer from JD(APC), JD(PAMS) & RO(HQ) Division shall be nominated for the same.
- 4. It was decided that next CAC will be held on developing the sector specific directions.

The meeting ended with vote of thanks to the Chair.
