- 1. It is learned from the reliable sources that some small healthcare units are disposing Bio-Medical Waste illegally and in unscientific manner. It was decided that Principal Scientific Officer to prepare monitoring protocol and place before next.
- 2. CAC deliberated on the measures to be adopted for control of fugitive emissions arising from cement, mining and similar type of industries and it was decided to direct such type of industries to make use of chemical (MgCl) dust suppression method or any other alternative technology for use of water, wherein the dust is suppressed for longer period without causing much pollution and hazards to the soil.
- 3. A policy note to be place before next CAC meeting regarding merits, demerits, difficulties, strategy etc for discharging treated effluent, after meeting consented standards, from the Outlet of ETP of Large Scale Industries (with definition / type of units to be included in Large Scale) at the final outlet discharge point of the Common Effluent Treatment Plant with online monitoring facility.
