Chairman of the committee welcomed the members of the committee and allowed proceeding of the meeting to start. The follow up action report of CAC meetings held earlier on 21.09.2011 to 02.03.2012 were placed before the CAC and noted.

Further, CAC discussed on following points;

- Board is granting consent to the industries with compliance of certain specific conditions and it was found that some industries are not complying to the conditions. Therefore, it was decided that Regional Officers shall submit the compliance report of specific conditions stipulated in consents of CAC industries monthly to the respective HOD. The compliance reports are to be placed before CAC, also bringing out non-compliances and non-reporting by ROs.
- 2. Abstract of SCN issued to CAC industries for non-compliance of BG is discussed in-detail and it was found that 52 no. of industries out-off 75 have not submitted the BG as per condition prescribed in the consent. Hence, it was decided to revoke the consent of these industries who have not submitted BG and decided to give the period of 30 days for appeal before taking further action.
- Validity period of SCN Sr. Law Officer to bring a note before CAC during the next CAC meeting.
