General Points:

- 1. CAC has given instructions to CAC Cell for revision of format of summary sheet to get more clarity and uniformity, such as a) existing consent details to be rearranged starting from consent no., date, validity and ending with CI, b) Applicability of EC/siting criteria to be mentioned uniformly by each FO of CAC CC cell i.e. either write Y or N only and the details of EC should include applied/obtained/not obtained/ not applied and whether EC is required based on construction area or mfg activity, C) While processing the application of first C to O, FO shall give the ref. of C to E which is to be converted to C to O in the column of "Applied for "of summary sheet.
- The new IMIS/Consent management system shall be modified to include menu approach for EC requirement and its status. CAC cell shall coordinate with the software consultant for this modification in the system.
- 3. Representation received for uploading the complete agenda of CAC/CC meeting on MPCB website (and not only index of cases) was considered during the meeting and it was decided that CAC/CC Cell shall upload the summary sheet, as placed in the agenda of CC and CAC cases, on MPCB website.
- 4. All MIDC areas shall distinguished by MIDC into zones which comes in RRZ basin. JD (WPC) to hand over the map of RRZ river basin to Shri. Nandusekar, Technical Advisor of MIDC.
