The consents shall be disposed after obtaining necessary consent fee difference from the industry as per GoM, Revised Consent fee structure dtd. 25.08.2011.

Further, CAC decided to prepare consolidated report for Sugar, Power, Automobile and Steel sector for CAC industries which shall cover following points;

- a) Inventorization of said industries in Maharashtra including present status of compliances
- b) Compliance of consent conditions, MoEF/CREP guidelines and specific compliances towards CRZ/Environmental Clearance related to Environment.
- c) Identification of constraint faced by the industry towards implementation of standards.
- d) Identification of grey areas where attention of regulatory authority is required.
- e) Performance evaluation of BAT provided by the industries, if any and its comparison with conventional technology available with the industry.
- f) Benchmarking of the pollution control system
- g) Preparation of directions as per legal matrix based on findings of the report about noncompliances observed to fill the gaps

A report on Sugar, Co-gen and Distillery plant shall be prepared by RO(HQ), Power, Automobile & Steel sector shall be prepared by JD(APC) and same shall be placed in next CAC.

Because of want of time other agenda items placed before the CAC could not be discussed, it was decided that these items can be considered in the next CAC meeting.

The meeting ended with vote of thanks to the Chair.
