We are following the norms of 20 CMD/ Acre in general for the disposal of treated effluent. This issue was discussed in the meeting in detail. While prescribing the condition of disposal the land strata / land quality is not taken into account. Hence it is decided in future while calculating the disposal area the land strata/ land quality will be taken in to account.

Review of formula for CREP compliance of Distillery units shall be prepared and to be placed before CAC.
