The consents shall be disposed after obtaining necessary consent fee difference from the industry as per GoM, Revised Consent fee structure dtd. 25.08.2011.

Thereafter, CAC discussed on following points;

- 1) JD(APC) shall prepare a compressive agenda note on installation of CAAQMS. The note shall include following point
  - Type of industries where CAAQMS is required to be installed.
  - In case of other industries in special circumstances considering distance of human habitation from the industry, sensitivity, location specific problem where CAAQMS may be required.
  - Time table for installation which include sequence for ordering ,site identification, installation, commission of CAAQMS along with time frame
  - Detail proposal of monitoring of CAAQMS stations along with industries specific parameters, fixing responsibility to monitor data and use of data generated from these stations.
  - Inventory of CAAQMS installed and rationalization of CAAQMS stations where multiple stations are installed.
  - Time frame for retrospective installation of CAAQMS in industries where condition of installation was not mentioned in consent to Establish / Operate/ Environmental Clearance, along with the policy and necessary BG to be obtained.
- 2) It was decided to issue consent validity upto 31<sup>st</sup> July of the respective year for Sugar, Co- generation, Distillery and other units located in same premises. This is with a view to rationalizing issue of consent and the monitoring of the same. However the consent period for standalone distillery shall be as per prevailing procedure.
- 3) It was decided that industry having number of consent on one plot/ same premises, the consent period co terminus with other units.
- 4) Comprehensive notes for Sugar (including Co- Generation and associated distillery units), Infrastructure (including construction) and Mining industry are to be prepared having following section and presented in the next CAC on 18.12.2012.

- (i) The core process of the industry with templates for water balance, Material balance with approved standards set by CPCB/MPCB. CPCB guideline to be integrated in this section explicitly.
- (ii) Scrutiny sheet with check list for examining, evaluating consent proposal (C to E, C to O or C to R) which will be used uniformly in the organization with computerized on line capability.
- (iii) Standard consent conditions and letter templates for each industry that are capable of being generated through IMIS automatically.

- (iv) Compliance matrix for the concerned industry capable of being consistently applied across various units and across various geographical location in the state.
- (v) Database with profile of existing consents (CAC/CC) for these industry groups.
- (vi) Monitoring mechanism in respect of the consenting units, specifying frequency of visit by field staff with monthly reports to be provided to CAC/CC regarding status of the units, Directions issued etc.
