Bombay Rayon Fashion, Thane, it was decided that the validity of captive power plants will be considered as per the sectoral approach of the main plant /manufacturing activity so that during amalgamation both the units will have co-terminus consent validity period. This shall be applicable to all other cases therefore consent period should be recommended accordingly. **Action Point-III** 4.i) Sectoral review of Sugar, Cement (integrated & grinding units) and Paper & Pulp Industries, ii) Review of Status of authorization and/or consent of MSW, BMW and STP of 26 Municipal Corporations, consent of Hospitals, and iii) Review of systemic flaws of three committees (Chairman of all the three committees to prepare a note on the systemic flaws of their respective committee) will be discussed in detail on **Action Point-IV** 16.7.2013. 5. Applications of Municipal Corporations & BMW/Hospitals to be discussed on 16.7.2013. 6. Applications of sugar, other industries & Municipal Corporation & BMW authorizations will be discussed on 23rd July, 2013 tentatively. 7.TA to prepare a conceptual note on self appraisal of industry which will be certified by renowned technical institute before making an application for consent to the Board. 8. As per instruction issued to the SRO/RO, from 1st of July, 2013 all cases should be in new formats only & the applications /cases which are not submitted in new formats should be returned back to SRO/RO for resubmission in new formats to CAC/ CC cell.
