General Points:

Committee observed that some proposal had no details of project/activity to which the
consent is to be granted. Hence to avoid such irregularities it was decided that
henceforth, agendas to be placed before CAC meeting shall include draft consent
copy.

- 2. In cases where reports on "no increase in pollution load" is required, MPCB shall refer such cases to NEERI for assessment and MPCB shall obtain the necessary required fees from industries to pay the charges to NEERI for such assessment.
- Committee also noted that some application are being returned to the industry without approval of the sanctioning authority, hence it was decided to reiterate the circular that the cases should not be returned without permission of consent granting authority as per delegation of powers.
- 4. During the discussion in the meeting, HODs informed that there is some need for amendment in procedure for refusal /review / revocation and BG forfeiture/ encashment of consent as per delegation of Powers,2008. Sr. Law Officer shall recirculate the office note/ file of the same for comments from HODs.
- 5. For the industries, excluding construction activity, which attracts EC, C to E shall be granted with the condition of submission of BG of Rs. 5 lakhs for not taking any effective steps towards implementation of project before obtaining EC and for the industries which attract EC and have already taken effective steps towards implementation of project the condition of submission of BG of Rs. 10 lakhs shall be imposed in the consent to establish. In case of construction projects earlier circular will be applicable but if the project proponent started the construction work without obtaining C to E and EC, in such cases double the amount of BG mentioned in the circular for condition of construction project.
- 6. All HODs have raised their concern about ambiguities in different circulars issued earlier viz., BG, Lapse period fees, etc., in this regard it was decided to call a separate meeting to take review on various circulars issued from time to time as well as action taken on general points, specific conditions, BG compliance etc.
- 7. It was noticed by the committee that some of the sugar units have not provided adequate APC system as per CREP guidelines. It was decided to issue direction/ to amend the consent for such non-complying sugar industries by stipulating time upto 30.04.2013 & BG of Rs. 3 lakhs to ensure the compliance.
