Thereafter, CAC discussed the following points;

1. The consents shall be disposed after obtaining necessary consent fee difference from the industry as per GoM, Revised Consent fee structure dtd. 25.08.2011.
2. During the discussion of Ispat (Jetty), Chairman desires to know the list of authorized jetty as per the Maharashtra Maritime Board and how many jetties have obtained consent to Establish from the Board. Also, the information of applicability of consent to fishing jetties shall be submitted by JD(APC).
3. Status of total cement units in Maharashtra w.r.t. CPCB direction of inspection twice in the year shall be placed by JD(APC) in next CAC.
4. During the discussion of construction/ infrastructure projects, Chairman desires the status of projects who have applied for consent to operate after obtaining consent to Establish. The status shall be submitted by RO(HQ) in next CAC.
5. Chairman instructed that the noting section should bring all the facts and observations on record and HOD's final noting should be comprehensive.
6. A note on competent authority for various activities to grant consent shall be submitted by JD(PAMS). This is important as Board grant consent based on NOC/permission from other Govt. Departments and it is necessary to know competent authorities of various activities like power plant, MMR, RRZ, CRZ, etc.
7. Follow-up action of all general points shall be placed and re-viewed in CAC meeting scheduled on 19.10.2011.
8. The next CAC is scheduled on 12.10.2011 and cases of JD(PAMS) & other cases in last CAC meeting of JD(WPC) which require further clarification will be discussed during the meeting.

The meeting ended with vote of thanks to the Chair.
