Minutes of remaining agenda items of 5<sup>th</sup> Consent Appraisal Committee Meeting of 2013-2014 held on 29.7.2013 at 11.00 am at Conference Hall, MPC Board, Kalpataru Point, 4<sup>th</sup> Floor, Sion Circle, Sion (E), Mumbai 22.

Chairman of the committee welcomed the members of the committee and allowed proceeding of the meeting to start. The minutes of the 8<sup>th</sup> Consent Appraisal Committee (CAC) meeting of 2013-2014 held on 16.07.2013 circulated under Board's letter No. MPCB/CAC cell/minutes/B-3254 dated 19.07.2013 were confirmed.

The balance fees on the part of MPCB, if any, shall be considered at the time of next renewal of consent, which shall be mentioned in the consents to be issued hereafter.

## **General Points:**

Action Point-I	1. The issue of products and By- Products of Sugar industries was discussed. To bring uniformity in the consents granted to Sugar
	units, it was decided to obtain detailed material balance from the sugar units. It was also decided that the sugar units while
	applying for consents should clearly mention the details of products and by products. If there are no by products mentioned in the
	application the details regarding disposal of waste generated should be clearly mentioned.
	2. It was noted that the TAC during scrutiny of sugar units observed that the sizes of most of the ETP units of the industries are
	oversized. During discussion in the meeting while individual sugar units are being informed to rectify the same, the review of the
	sizes of the units of ETP's of individual sugar units will be taken up during review of all sugar units. It was decided that the review
	of all sugar units will be taken in Oct-2013.
	3. All cases of C to E with EC issue should be imposed with BG of Rs. 5 lakh for compliance of condition to not to take effective
	steps towards implementation of project prior to obtaining EC.
