Note ;-

Committee has noted that industries under CAC purview are being issued Proposed/ Interim / Closure Directions by the Regional Offices without intimation to CAC. Also, it is observed that Closure Directions is issued to industry without intimation/Approval of CAC and Consent application is being process without giving its reference and Consent renewal without issuing Restart directions.

Committee decided that, to avoid such lapses and to ensure that Natural Justice is extended to the industry, all the files of Closure Directions or granting Restart Order to industry under purview of CAC shall be placed before the CAC Authority for final decision.

Committee also decided to direct all the Regional Officers to ensure that Natural Justice extended to the industry and prior permission from CAC Authority is obtained before issuing Closure Directions to industry following under CAC purview. Also, they are directed to recommend CAC cases for issuing Restart Directions along with detailed compliance report including JVS.
