The committee deliberated on BGs submitted by the PP at various stages of the project completion. It has been decided to impose single BG towards operation and maintenance and compliance of consent condition and returned other BGs obtained/imposed earlier for the project under consideration.

Committee also deliberated on change in name of the project. It has been decided to consider such proposals if PP produced amended EC within three months from the date of issue of the consent order and need not to come before CAC again for such amendment within the period three months.
