Committee further noted that case was discussed in Technical Committee's 6<sup>th</sup> meeting held on 27/03/2019 which has decided to recommend the case for change in product under product-mix with a condition to dispose the byproducts as hazardous waste and industry shall comply with the provision of HW Rules for sale/ disposal of by-products.

In view of above, it was decided to grant renewal of Consent to Operate with proposed change in product mix by imposing the following conditions:

- 1. Industry shall recycle 100% of treated effluent into process, cooling tower & for utility purposes so as to achieve ZLD
- 2. Existing pollution load shall not increase due to proposed change in product-mix.
