SRO Mahad vide email dtd-5/11/2014 submitted the reply with CA certificate on C.I from 2011 to 2014,mentioning that letter is been given to industry for payment of Rs.9000/- difference fee on increase in C.I.SRO also reported that industry has taken production of two new products however the report was silent on NIPL. Hence SCN for refusal of consent was issued to industry vide letter dtd-12/11/2014 for providing of briquette fire boiler and taking production of two new products and not submitting NIPL. Meanwhile the file was send to CAO for verification of fees paid w.r.to increase in C.I. In this regards CAO asked PP to submit balance sheet of industry as per circular dtd-29/12/2011along with schedule of fixed assets from industry. In the time being this office received reply to SCN vide letter dtd-12/11/14 from PP. In the reply PP submitted that they had incorporated the briquette boiler details in their</p>

Regarding manufacturing of two new products PP submitted that due to increase in market demand from 2013 and for survival they had manufacture two product however not exceeded the total consented quantity of 39.76 MT/M. Now they had stopped the same. Regarding NIPL PP submitted all details in Boards performa and certificate from Dr. Babasaheb Ambedkar Technological university giving required details justifying NIPL. The PP also submitted the details of C.I as per the suggestion of CAO along with CA certificate for multiple units and balance sheet. It was observed from details submitted that the C.I increases from 24.98 Cr to 47.25 Cr for which PP submitted the difference fees of Rs.1,25,000/- for applied period. Hence due to increase in C.I the case now comes under perview of CC. [new entry].</p>
