generated from the HCE should be CWWTP (Common Waste Water Treatment Plant).

2. In the cases where there is doubt regarding

adequacy of CWWTP, water balance and capacity the Bank guarantee of Rs. 50,000/- shall be imposed for carrying out study within 3 months.

3. CWWTP should be properly defined along with stages shall be reflected in consent as one condition.

4. The consent shall be granted as per bed strength mention in the authorization.

5. In cases of extra bed consent should be issued only after amendment of bed numbers in authorization.

6. As per the approved policy the attempt should be made to combine consent & authorization. However if hospitals are not willing to pay fees, separate consent can be issued.

7. The consent shall only be issued after obtaining date of commissioning of hospital.

a. The case no. 1, 3, 7, 10, 11, 14 & 17 where date of commissioning are not specified, it should be verified.

b. In case commissioning date is prior to 04.06.2012, such cases & case no. 18 should be fully verified for EC and CRZ applicability and put up before CC again.

8. All the consent will be issued subject to the payment of fees.
