(iii) MIDC shall provide the arrangement to restrict overflow of treated effluent from HRTS area before commissioning CETP and in no case MIDC shall discharge treated effluent adjoining local nalla. (iv) MIDDC authority shall submit Bank Guarantee of Rs, 10 lakh to RO, Amravati for ensuring O & M of pollution control system. (v) MIDC shall monitor monthly the status of ground water adjoining area of HRTS facility from any MoEF approved laboratory and submit report to SRO.
