# OF ORDER DTD.1/3/2012 PASSEED BY THIS HON'BLE COURT

I. Yeshwant B. Sontakke, aged about 47 Years, occupation-service, the Regional Officer (HQ) and Incharge Joint Director (Water Pollution Control) of the Maharashtra Pollution Control Board, having my Office at Kalpataru Point, 3<sup>rd</sup> Floor, Sion-Matunga Scheme Road No.8, Opp.Cine Max Cinema, Sion (East), Mumbai -400 022, looking after the subject work more particularly the Common Effluent Treatment Plants in the State of Maharashtra, do hereby on state solemn affirmation as under.



I am filing this Affidavit in compliance of the order passed by this Hon'ble Court dtd.1/3/2012 for the purpose of bringing on record the further steps taken by the Respondent No.3-Board to implement a Pilot Project at Mahad MIDC to ensure improved performance of Effluent Treatment Plant of industries and MMA CETP. I crave leave to file an additional Affidavit as and when necessary. I shall not be deemed to admit anything save except whatever stated hereunder:

I say and submit that after extending an opportunity of hearing to all concerned in the above petition by this Hon'ble Court on 1/3/2012 in the Conference Room at High Court, the Respondent No.3 has taken a review of the working of CETPs in the State of Maharashtra. I say and submit that the following immediate actions are initiated by the Respondent-Board in compliance of the order dtd.1/3/2012 passed by this Hon'ble Court.

- (I) Communication to the concerned Regional Officers and CETPs, the points of compliance to be secured
  - Being the overall incharge of CETP activities for the enforcement of environmental norms, I have brought to the notice of all the Regional Officers having MIDC/Non-MIDC with CETP areas in the State of Maharashtra, the immediate actions to be initiated by them including monitoring of CETPs and the defaulting pollution potential industries in such areas, collecting composite samples and joint vigilance samples as per the protocol prepared by the Principal Scientific Officer and getting it analysed on top priority basis, so as to make available the report thereof in a time bound manner. I have specifically asked them to bring to the notice of the CETPs in their respective jurisdiction, the points of compliance to be implemented by them including installation of certain electronic equipments to monitor the unit operations through Central Monitoring System, installation of online monitoring system for certain important parameters, training to the operators for efficient working of the CETPs and to obtain time bound programs

for making improvement in the CETP operations with



- b. I say and submit that besides above specific communications to the Regional Officers of the MPCB by letter dtd.3/3/2012, I have also brought to the notice of individual CETP Associations in the MIDC areas, the points of necessary compliance to be secured in a time bound manner. A sample copy of such communication dtd.3/3/2012 alongwith a list of CETPs in the MIDC and Non-MIDC areas is enclosed herewith and marked as an Exhibit-'I'
- c. The order passed by this Hon'ble Court dtd.1/3/2012 had been communicated to the concerned Regional Officers and HoDs for ensuring the compliance thereof by e.mail on 5/3/2012, after receipt thereof.

#### (II) Ensuring the compliance of CETP, Mahad -

(a)

I say and submit that as per inquiry with the MIDC, it has been informed that the MIDC and the Mahad Manufacturers Association in co-ordination with each other has already agreed to make necessary arrangement for providing sumps for storing effluents being received from individual industries for the purpose of treatment in the CETP. The Executive Engineer, MIDC, Mahad (Civil Division) specifically reported the compliance of directions issued by this Hon'ble High Court in respect of providing zonewise sumps in the industrial area of MIDC Mahad to the Deputy C.A.O., MIDC. It is proposed to construct an additional sump in CETP premises with equivalent size and capacity of existing receiving sumps to receive the additional effluent load of 6.5 to 7 MID of M/s Pudumiee



chambers of respective zonal points are proposed, which may be converted into acting sumps by increasing size at maximum possible extent with fixation of control walls. It is also stated that a new separate line from M/s.Akzo Nobel connecting Additional MIDC low COD effluent line at KSF Junction by carrying low COD effluent is to be laid down, which is to be connected to new proposed sump in the CETP, thereby, low COD effluent in the old MIDC can be segregated and can be directly discharged into the new proposed sump in CETP. I crave leave to refer to and rely upon the office note received from the Executive Engineer, MIDC when produced.

- (b) I say and submit that the Respondent-Board specifically communicated the co-operative society running CETP that it shall discontinue receiving effluents being sent by an individual industrial unit into the CETP inlet having high pollution load, which will disturb the operation of CETP by giving prior notice to stop such type of discharge and to communicate such names to the Regional Officer of the Respondent-Board at Raigad for initiating further necessary action.
- (III) Compliance of the closure directions issued by Regional Officer, MPCB, Raigad against 9 defaulting industries in the Mahad area:
  - I say and submit that the Regional officer, MPCB, Raigad has issued directions of closure to 9 defaulting industries in Mahad Area on 16.02.2012 and thereafter restart directions are given to 7 industries by Member Secretary of

- b. I say and submit that M/s.Shrihari Chemicals Exports Ltd. has already been issued with the directions of closure and since, then, it is closed and not allowed to restart. I say and submit that the Sub-Regional Officer of the Respondent-Board at Mahad has been directed to keep constant vigil on the said unit. I further say and submit that Sub-Regional Officer, MPCB, Madad caused visit & inspection on 20/3/2012 and observed that the unit was not in operation at the time of visit. I further say and submit that M/s.Shrihari Chemical Exports Ltd. has initiated Notice of Motion bearing no.107/2012 in this particular matter, which is pending.
  - I say and submit that one of the industry against whom directions of closure has been issued namely M/s.Embio Ltd., MIDC Mahad, Dist: Raigad has filed an appeal before the National Green Tribunal, New Delhi, aggrieved by the directions of closure issued by the Respondent-Board vide letter dtd.16/2/2012. I say and submit that the Hon'ble National Green Tribunal has stayed the execution of the directions of closure issued by the Respondent-Board dtd.16/2/2012 for a period of two weeks. After expiry of the said period, the MIDC has disconnected the water supply of the unit. The unit has approached to the Board with the request that it has secured more than 95% compliance and therefore, may be allowed to restart its manufacturing activities. The said representation is under consideration of the Respondent-Board with reference to the Appeal preferred by the said unit before National Green Tribunal

the basis of continuous daily monitoring for 3 weeks: - I say and submit that in compliance of the order passed by this Hon'ble Court, the officers of the Maharashtra Pollution Control Board at Mahad have caused continuous daily monitoring of the CETP at Mahad for a period of 3 weeks. During the monitoring of CETP, they have taken samples from the inlet & outlet of the CETP and got it analysed from the Central Laboratory of the Board at Navi Mumbai. A comparative statement in respect of the results on monitoring in comparison with the standards laid down under the provisions of the Environment (Protection) Rules, 1986/Consent Standards, indicating the performance and functioning of CETP at Mahad is enclosed herewith and marked as an <a href="Exhibit-fill">Exhibit-fill</a>, which is self-explanatory.

After going through the report on monitoring, it can be seen that the performance of CETP at Mahad has been considerably improved after initiating stringent actions against the defaulting units including the seven units, which have been allowed to restart their manufacturing activities having achieved the substantial compliance level. On account of the provision made for storage of treated effluent by providing necessary sumps from individual industries for the purpose of treatment in CETP, online monitoring system and effective monitoring, the performance has been considerably improved. It has been observed that initially prior to taking effective steps the monitoring of CETP shown the results of important parameters on much more higher side. Later on, when the Respondent Board initiated action against the CETP and highly pollution potential industries, the



been considerable improvement in the working of the CETP, thereby further visible improvement in the monitoring results. After taking continuous monitoring of CETP by composite sampling for last more than two weeks, there has been more improvement in the monitoring results on account of improvement measures taken by the individual pollution potential units as well as CETP Authorities, as confirmed by the Sub-Regional Officer of the Respondent Board at Mahad on the basis of comparative Statement of results on monitoring. (which is already enclosed as an Exhibit – III)

(V) Report indicating the functioning of other CETPs in other MIDC Estates and in Non-MIDC areas on the basis of monitoring done on weekly basis: I say and submit that I have specifically informed the concerned Regional Officers in the MIDC /Non-MIDC areas that they should monitor the functioning of CETPs in their jurisdiction atleast on weekly basis and submit their report about the same indicating the performance thereof.

I say and submit that they have monitored the CETPs in their areas and submitted the report on monitoring. The statements showing the performance of the CETPs other than Mahad area on the basis of weekly monitoring in comparison with the standards laid down under the provisions of the Environment (Protection) Rules, 1986/Consent Standards for discharge of CETP effluent is enclosed and marked as Exhibit-IV, V & VI respectively.



After going through the report on monitoring of other CETPs received from the concerned Regional Officers the

(I) CETPs, which are overall complying with the Environmental Norms and Standards laid down under the provisions of the Environment (Protection) Rules, 1986/Consent Standards (having fluctuation (exceeding standards)upto 10% overall compliance of basic standards such as : pH, BOD, COD & Suspended Solid etc.)

After going through the monitoring of all the CETPs except Mahad in the State of Maharashtra, it has been observed that total 6 CETPs have been found to be overall complying with the standards, having complied with 3 out of 4 main parameters of CETP and 1 parameter slightly exceeding, therefore, treated as overall complied with the Environmental Norms, out of 21 working CETPs.

(II) CETPs, which are overall complying with the Environmental Norms and Standards laid down under the provisions of the Environment (Protection) Rules, 1986/
Consent Standards (having overall fluctuation(exceeding standards) in the parameters of pH-5.5 to 9.0, BOD- upto 500 mg/l. against 100 mg/l. standard, COD- upto 750 mg/l. against 250 mg/l. standard and Suspended Solids- utpo 300 mg/l. against 100 mg/l.)

After going through the monitoring of all the CETPs except Mahad in the State of Maharashtra, it has been observed that total 9 CETPs have been found to be overall complying with the standards having the exceedance mentioned above, which can be said to be medium violating standards of CETPs, out of 21 working CETPs.



the Environment (Protection) Rules, 1986 / Consent Standards (having overall fluctuation(exceeding standards) in the parameters of pH-5.5 to 9.0, BOD- above 500 mg/l. against 100 mg/l. standard, COD- above 750 mg/l. against 250 mg/l. standard and Suspended Solids- above 300 mg/l. against 100 mg/l.)

After going through the monitoring of all the CETPs except Mahad in the State of Maharashtra, it has been observed that total 6 CETPs have been found to be highly non-complied with the standards having the exceedance mentioned above, which can be said to be highly violating standards of CETPs, out of 21 working CETPs.

I say and submit that 4 CETPs, (namely: (1) Tarapur Industrial Manufacturers Assocation-CETP of 2 MLD capacity, which has been diverted to the newly established and operated 25MLD CETP; (2) Ambernath MIDC CETP Co.Pvt.Ltd. (Bharat Udyog Ltd.) of 7 MLD capacity; (3) Ichalkaranji Textile Development Cluster Ltd. of 1.2 MLD capacity; & (4) Krishna Valley Enviro-Tech Pvt.Ltd., MIDC Kupwad, Dist: Sangli of 1.5 MLD capacity), are yet to be made operational on account of their own difficulties.

Accordingly, the Respondent-Board is initiating appropriate directions to them by extending an opportunity of hearing and thereby, obtaining necessary time bound programs duly supported by the bank guarantees, to ensure that time bound Action Plans are implemented.



I say and submit that considering necessity i

- (i) CETP operator shall carry the required treatment to meet final effluent quality standards for CETPs and shall be responsible for O & M operations.
- (ii) CETP operator shall monitor specified quality outlet parameters and flow rate on daily basis and submit the monitoring data to the MPCB on regular basis. Parameters to be specified by SPCB shall be monitored by the CETP operator online at outlet of a CETP and IT based linkage shall be provided by the operator to the SPCB. The SPCB shall ensure that continuous 24 hour data is displayed on its website.
- (iii) A three tier monitoring mechanism viz. at industry level, monitoring by SPCB and third party monitoring shall be undertaken.
- (iv) The CETP operator shall furnish a suitable bank guarantee to the SPCB for the satisfactory performance of the CETP.

I say and submit that the Maharashtra Pollution Control Board has restarted placing the Reports on Monitoring of CETPs in the State of Maharshtra on the website of the Board (<a href="http://www.mpcb.gov.in">http://www.mpcb.gov.in</a>).

(VI) Communication received from Nicholas H. Almeida, the Petitioner in respect of commencement of construction by M/s.Lenzing Modi Fiber India Pvt.Ltd. at MIDC Additional Patalganga, Dist: Raigad :- I say and submit that one declared Industrial Chemical Zone. It has been contended that site preparation for putting up a 'Red' Category highly polluting industry such as a Rayon Plant of M/s.Lenzing Modi Fiber India Pvt.Ltd. was in full swing in Patalganga area. It is also mentioned that it appears that the above project has not yet been granted prior Environment Clearance. It is further complained that an ongoing construction, which turned out to be the road flyover over the Railway Line being built up, so that trains could pass below the flyover before entering the tunnel nearby etc.

After examination of the record, it has been observed that M/s.Lenzing Modi Fibers India Pvt.Ltd. is a joint venture company, yet to set up a plant in technical and financial collaboration with Modi Group and Lenzing AG Austria. It has applied for Environment Clearance from the Ministry of Environment & Forests, Govt.of India and completed the EIA study on the basis of Terms of Reference (ToR) through M/s.TATA Consulting Engineers Ltd. and also got study done through National Institute of Oceanography (NIO). The Expert Appraisal Committee has recommended the Environment Clearance. At present, the leveling of land has started, with the approval of MoEF, Gol. I say and submit that construction of the boundary wall to secure the land appears to be undertaken, which is yet to be commenced. A copy of the verification report received from the Sub-Regional Office of the Respondent-Board at Raigad is enclosed herewith and marked as an Exhibit-'VII'.

In response to the order passed by the Hon'ble High Court of Judicature at Bombay, you are directed to submit your compliance on the following points.

- Installation of certain electronics gadgets/ equipments to monitor the unit operations through central monitoring system, so as to monitor the units operations of CETPs at a glance.
- ii) To direct operator and laboratory staff to collect samples and analyse it for giving feedback for improving operational efficiency by the operators.
- Providing actuator valve with variable timer system for timely removal of sludge from primary and secondary clarifier.
- iv) Installation of online monitoring system for pH, DO and Flow for treated effluent so as to process and operate the unit efficiently.
- v) To do bench scale laboratory treatability study, this concept is necessary

vi) To train operator for efficient unit operations with the audio visual signal system to be introduced to know the health of biological reactors by providing microscope with CC TV camera and display system.

You are also directed to submit action taken report alongwith the details in respect of expenditure already incurred in making improvement of upgradation of CETPs with enhancement of the capacity during last 2 years. You should also submit report in respect of the improvement made in the CETP during last 2 years alongwith the statement showing the JVS reports in comparison with the results prior to improvement and the results after improvement.

You are also directed to put on line monitoring results on your website within 7 days (i.e. on or before 15<sup>th</sup> March, 2012) Also scanned copies of analysis results of last six months shall be displayed.

The action taken report on above issues shall be submitted to the undersigned on 16th March, 2012 without fail.

MIDC Mahad is chemical zone about 50 units are in regular operation. Each unit has individual ETP for their effluent treatment & common CETP for further treatment.

CETP has consisting primary, secondary & tertiary units, but O & M of CETP was poor & huge quantity of sludge was accumulated in CETP sumps. Also existing ETPs of individual industries were inadequate to treat their effluent.

Due to inadequate & poor O & M of individual existing ETPs in year 2010 the incoming COD of CETP was 4000 mg/lit. Also due to poor O & M of CETP, the Outlet COD of CETP was 4400 mg/lit. Its shows poor treatment by industries & CETP.

MPCB has issued Closure & Voluntary Closure Directions to industries & actions on CETP in Nov. 2010. After Restart Directions with certain conditions, industries have upgraded their existing ETP & also improve O & M of their ETPs. CETP has improved O & M of CETP units & removed 10000 MT sludge from sumps with providing additional aerators. Now CETP has trying to achieve consent standards.

With reference to above subject matter, it is to submit that M/s. Lenzing Modi Fibres (I) Pvt. Ltd., Plot No. M-1 Addl. MIDC Patalganga, Dist. Raigad is a joint venture company, yet to set up a plant in technical and financial collaboration with Modi Group and Lenzing AG Austria. It has applied for Environment Clearance from the Ministry of Environment & Forests, Govt. of India and completed the EIA Study on the basis of Terms of Reference (ToR) through M/s.Tata Consulting Engineers Ltd. and also got study done through National Institute of Oceanography (NIO). The Expert Appraisal Committee has recommended the Environment Clearance. At present the leveling of land has started, with the approval of MoEF, Gol.

The Field Officer of this office has visited the site on 22/3/2012 and observed that the construction of the boundary wall to secure the land appears to be undertaken, which is yet to be commenced.
