- 2 The Show Cause Notice is already issued to CETP on 03.12.2015 as per earlier complaint in the same matter and the proposal to initiate further action against M/s CETP Thane-Belapur Association is submitted to HQ on 11.01.2016 as CETP is not complying with the consent conditions (bypassing untreated effluent into local nalla).

WHEREAS, it is obligatory on your part to comply with the conditions stipulated under Consent to Operate granted by the Board under Section 26 of the Water (Prevention & Control of Pollution) Act, 1974, under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and under Rule 5 of the Hazardous Wastes (Management, Handling & Trans-Boundry Movement) Rules, 2008. AND WHEREAS, it is also obligatory on your part to provide adequate pollution control systems and operate & maintain the same continuously and effectively so as to achieve the standards prescribed under Environment (Protection) Act, 1986 and to avoid any sort of pollution problem in the surrounding area.

AND WHEREAS, vide reference-ii above this office has received complaint regarding air pollution due to your activity.

AND WHEREAS, in accordance to investigate the complaints the Board officials has visited your site on 06.01.2016 and as per observations made during visit the Sub Regional Officer of the Board at NaviMumbai-I reported the following non-compliance-

- 1. You are carrying out manufacturing activities without providing air pollution control devices.
- 2. You are generating heavy emissions during manufacturing process and same are being emitted into environment.
- 3. You are storing raw material in haphazard manor in open area in premises.
- 4. The spillages & overflow is observed near the Effluent Treatment Plant area.

Thus, you are not serious about the pollution control and violating the provisions of various environmental enactments.

AND WHEREAS, from the record of this office and observations made during the visit of Board Officer to your unit, I am satisfied that you are not operating and maintaining the pollution control system properly thereby damaging the surrounding environment by means of discharging the pollutants into the environment knowingly and willfully.

NOW, THEREFORE, in exercise of the powers conferred upon me under Section 33A of the Water (Prevention & Control of Pollution) Act), 1974 and under Section 31A of the Air (Prevention & Control of Pollution) Act, 1981, I, Nagesh S. Lohalkar, Regional Officer of the Board at Navi Mumbai, hereby issue directions as under —

- 1. Why your industry shall not be directed to close down its manufacturing activity forthwith?
- 2. Why the competent authority shall not be directed to disconnect water/electricity supply of your unit?

You shall submit your reply/objections within a period of seven days from the date of receipt of these directions, failing which the Board shall consider to issue appropriate final directions, as may deem fit in your case, which may be noted.

WHEREAS, Maharashtra Pollution Control Board has granted consent to you under the provisions of Water (Prevention &Control of Pollution) Act, 1974 & Air (Prevention &Control of Pollution) Act, 1981&Authorization under Hazardous Waste (Management, Handling &Transboundary Movement) Rules, 2008 and amended therein, stipulated various conditions for implementation.

AND WHEREAS, it was obligatory on your part to provide adequate pollution control system, so as to comply the conditions prescribed in the consent. You were under an obligation to operate and maintain the ETP and the pollution control devices effectively, so as to achieve standards prescribed in the consent granted to you.

AND WHEREAS, Board office is in receipt of complaint vide reference (ii) above and accordingly Field Officer of this office has visited the affected location on -02.12.2015 for investigation of the complaint along with your representative and during his visit it is observed that, the CETP effluent carrying pipe line chamber adjacent to M/s Signetech, Plot No A-4, TTC MIDC is found overflowing thereby effluent is finding its way in nearby nalla upstream of M/s Alok Industries, TTC MIDC and creating water pollution nuisance in the area also the discharge of effluent into nalla from the backside compound wall of M/s Gaurav Dyeing, Plot No A-146, TTC MIDC is observed i.e it seems that, the said unit is not sending entire effluent to CETP for further treatment & disposal.

AND WHEREAS, above lapses amount to violation of Consent condition & negligence towards compliance of Environmental laws more precisely under Water (Prevention & Control of Pollution) Act, 1974 & Air (Prevention & Control of Pollution) Act, 1981& Authorization under Hazardous Waste (Management, Handling & Transboundary Movement) Rules, 2008.

AND NOW, THEREFORE, you are hereby called upon to Show Cause as to why necessary legal action shall not be initiated against you for above lacunas. Your reply, if any, shall reach this office

within a period of 07 days from the date of receipt of this notice, failing which, the Board will have no any other option than to initiate necessary stringent legal action against you, which may be noted.
