Order below Exh.1 in R.C. C. No.67/2015

In view of order passed on Exh.18, accused No.2 and 3 voluntarily pleaded guilty of the offence punishable under Section 15 of the Environment (Protection) Act. Hence, accused No.2 and 3 being partner of the Company M/s. Tharwani Constructions Pvt. Ltd. (Accused No.1), they are liable to be convicted. Hence, I pass following order: -

ORDER

1. Accused No.2 Sunil Hardasmal Tharwani and accused No.3 Dinesh Raghani are convicted of the offence punishable under Section 15 of the Environment (Protection) Act, they shall pay fine of Rs.50,000/- each in default to suffer simple imprisonment for three months.

2. Their bail bonds are cancelled
