## ORDER

The Appellant has preferred an appeal before the First Appellate Authority u/s 19 (1) of the Right to Information Act, 2005 vide dtd. 23.4.2012 on the following grounds and the discussions held about the said issues, is reproduced as under :-

- i) Action taken on the representations made by the Applicant to the Establishment Branch dtd. 9.9.2009, 5.8.2011 & 25.8.2009 respectively : - The Establishment Branch, has made available the information about the application made by the Appellant (Original Applicant) by it's letter dtd 26.4.2012. It has been clearly admitted therein that no action has been initiated / taken on the representations received from the Applicant dtd. 9.9.2009 & 5.8.2011 respectively. However, in respect of representation dtd. 25.8.2009, the copies of Office Orders issued by the Establishment Branch dtd. 24.2.2011, respectively have been made available to the Appellant.  
Mrs. Samel, Sr. Clerk, asked the concerned Sr. Clerk (Mrs. Pol) to make available the record after issuance of Office Orders dtd.

24.2.2011 respectively, which have been supplied to the Appellant, by letter dtd. 26.4.2012. Accordingly, Mrs. Pol, Sr. Clerk, who is dealing with the subject shown to the Appellant further record about fixation of his pay scale and made available all the Office orders and record pertaining thereto in respect of fixation of Pay Scale to the Appellant immediately.

- ii) Name of Officers and staff promoted to the higher post by relaxing qualification, experience, criteria during last 12 years and considered them as special case :-

The Establishment Branch has already provided the above information by letter dtd. 26.4.2012 to the Public Information Officer and the same has been made available to the Appellant.

In view of the above circumstances, the Appeal is hereby disposed off without any further order.
