Sub: Constitution of Committee for deciding guidelines for issuance of registrations to Producers or Brand Owners

Ref : The Plastic Waste Management Rules, 2016.


The Ministry of Environment, Forest & Climate Change (MoEF& CC) has notified new the Plastic Waste Management Rules, 2016. vide Notification dated 18/03/2016. As per these Rules, the producer, within a period of three months from the date of final publication of these rules in the Official Gazette shall apply to the Pollution Control Board or the Pollution Control Committee, as the case may be, of the State concerned, for grant of registration from the State Pollution Control Board (SPCB). And also No producer shall on and after the expiry of a period of Six Months from the date of final publication of these rules in the Official Gazette manufacture or use any plastic or multilayered packaging for packaging of commodities without registration from the concerned State Pollution Control Board.

In view of above newly notified Plastic Waste Management Rules, 2016, the Committee consisting of following members is constituted to decide guidelines and line of action for issuance of registrations and to recommend the authority to grant the registration under Plastic Waste Management Rules, 2016 in the Maharashtra Pollution Control Board.
