- (iv) Effluent Disposal: The treated trade effluent shall be recycled to the maximum extent and remaining shall be used for boiler feed of the M/s. Sama Chemo Pharma Pvt. Ltd. MIDC Islampur & remaining shall be used for gardening only on the land provided by the unit holder. In no case, at any time effluent shall finds its way to any water body directly or indirectly.
- (v) Sewage Effluent Treatment: The applicant shall provide comprehensive treatment system as is warranted with reference to influent quality and operate and maintain the same continuously so as to achieve the quality of treated effluent to the following standards.

(1) Suspended Solids Not to exceed 100 mg/l.
(2) BOD 3 days 270 C. Not to exceed 100 mg/l.

ix. As inspection book shall be opened and made available to the Board's officers

x. The applicant shall install a separate electric meter showing the consumption of energy for operation of domestic and industrial effluent treatment plants and air pollution control system. A register showing consumption of chemicals used

Xi. Separate drainage system shall be provided for collection of trade and sewage effluents. Terminal manholes shall be provided at the end of collection system with arrangement for measuring the flow. No effluent shall be admitted in the pipes / sewers down- stream of the terminal manholes. No effluent shall find its way other than in designed and provided collection
