The chimney(s) vents attached to various sources of emission shall be designated by numbers such as S-1. S-2 etc. and these shall be painted/displayed to facilitate elemetrication.

The industry shall take adequate measures for control of noise levels from as any sources within the premises so as to maintain ambient air quality standard in respect of noise to less than 75 dB(A) during day time and 70 aB(A) during night time. Day time is reckoned in between 6 a.m. and 10 p.m. and night time is reckoned between 10 p.m. and 6 a.m.

- at Noise from the D.G. Set should be controlled by providing an acoustic enclosure or by treating the room acoustically.

The acoustic enclosurer acoustic treatment of the room should be designed for minimum 115 (4B (A)) insertion loss or for meeting the ambient noise standards, where ver is on higher side. A suitable exhaust muffler with insertion loss (125 (13 A) shall also be provided. The industry shall take adequate measures for control of noise levels from its own sources within the premises in respect of noise to less than 55 dB(A) during day time and 45 dB(A) during the night time. Day time is reckoned between 6 a.m. to 10 p.m and night time is reckoned between 10 p.m to 6 a.m.

- is lineaster should make efforts to bring down noise level due to DG set, outside industrial premises, within ambient noise requirements by proper sitting and control measures.
- e. Installation of DG Set must be strictly in compliance with recommendations of DG Set manufacturer.
- f. A proper routine and preventive maintenance procedure for DG set should be set and followed in consultation with the DG manufacturer which would help to prevent noise levels of DG set from deteriorating with use

- 1. The cathenization is hereby granted to operate a facility for collection, storage, to insport & disposal of hazardous waste.
- 2. The meastry should comply with the Hazardous Waste (M&H) Rules, 2003.
- The unit has to display and maintain the data online outside the factory main gate in Marathi & English both on a 6'x4' display board in the manner and the report of the compliance along with photograph shall be submitted to this office & concerned Regional Office/Sub Regional Office.
 - It shall be ensured that the Hazardous waste is handled, managed & disposed of stractly in accordance with the Hazardous Waste (Management & Handling) bales, 1989 as amended on 2003 and shown & submitted to the Board as & when isked ton.
- Whenever due to any accident or other unforeseen act or even, such emissions pactar or is apprehended to occur in excess of standards laid down, such information shall be forthwith Reported to Board, concerned Police Station, effice of Directorate of Health Services, Department of Explosives, Inspectorate of Factories and Local Body. In case of failure of pollution control equipments, the production process connected to it shall be stopped.

- 9. Industry shall comply with following additional conditions:
 - The applicant shall maintain good housekeeping and take adequate measures that antrol of pollution from all sources so as not to cause nuisance to surrounding area / inhabitants.
 - b. The applicant shall bring minimum 33% of the available open land under green coverage tree plantation.
 - Solid waste The non hazardous solid waste arising in the factory premises, sweepings, etc., be disposed of scientifically so as not to cause any nuisance / pollutron. The applicant shall take necessary permissions from civic authorities to disposal to dumping ground.
 - The applicant shall provide for an alternate electric power source sufficient to applicate all pollution control facilities installed by he applicant to maintain compliance with the terms and conditions of the consent. In the absence, the applicant shall stop, reduce or otherwise, control production to abide by terms a conditions of this consent regarding pollution levels.
 - The applicant shall not change or alter quantity, quality, the rate of discharge, temperature or the mode of the effluent / emissions or hazardous wastes or control equipments provided for without previous written permission of the Bonei.
 - The applicant shall provide facility for collection of environmental samples and samples of trade and sewage effluents, air emissions and hazardous wastes to the local staff at the terminal or designated points and shall pay to the Board turne services rendered in this behalf.
 - The applicant shall make an application for renewal of the consent at least 60 days pefore the date of the expiry of the consent.
 - The state shall submit to this office, the 30th day of September every year, the subvict amental Statement Report for the financial year ending 31st March in the prescribed Form V as pre-the provisions of rule 14 of the Environment Protections (Second Amendment) Rules, 1992.
 - ix. As inspection book shall be opened and made available to the Board's officers during their visit to the applicant.
 - The applicant shall install a separate electric meter showing the consumption of energy for operation of domestic and industrial effluent treatment plants and an pollution control system. A register showing consumption of chemicals used for treatment shall be maintained.
 - x: Separate drainage system shall be provided for collection of trade and sewage inhemis. Terminal manholes shall be provided at the end of collection system with arrangement for measuring the flow. No effluent shall be admitted in the
