WHEREAS, This Office is in receipt of your application for grant of Consent to Establish for construction of Residential Project at S. No. 258/2/2/1+2+3+258/2/3/3, Vill. - Deoli, Nashik under Section 25 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and under Rule 5 of the Hazardous Waste (Management, Handling and Transboundary Movement) Rules, 2008

AND WHEREAS, you have started your construction activities having the total Construction Built up Area of 33,811.40 Sq. mtrs without obtaining prior Environment Clearance from the competent Authority as per the Environment Impact Assessment Notification dated 14/9/2006 and without prior Consent to Establish from the Board.

ANDWHEREAS Board office has issued Directions u/s 33A of the Water Act 1974 & under section 31 A of the Air Act 1981. You have failed to submit reply to the said directions issued by the Board. This shows your negligent attitude towards Environmental aspects.

AND WHEREAS, your application was put up before the Consent Committee Meeting of the Board held on 29/4/2013 and it has been decided to issue refusal of Consent to Establish for non submission of reply to directions issued by the Board.

In view of the aforesaid non compliance, your application for grant of Consent to Establish is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.

You may prefer Appeal against the Refusal Order passed by the Maharashtra Pollution Control Board, in case aggrieved by the refusal order, within a period of 30 days from the date of receipt of the Refusal order.
