1. The Consent to Operate is granted for a period up to:30/11/2017.

3. CONDITIONS UNDER WATER ACTS

(i) The daily quantity of trade effluent from the factory shall not exceed 680.00M³.

(ii) The daily quantity of sewage effluent from the factory shall not exceed 20.00M³.

(iii) Trade Effluent

Treatment: The applicant shall provide comprehensive treatment system. consisting of primary / secondary and/or tertiary treatment as is warranted with reference to influent quality and operate and maintain the same continuously so as to achieve the quality of the treated effluent to the following standards:

(iv) Trade Effluent Disposal: The treated effluent shall be sent to CETP Waluj for further treatment and disposal. In no case, at any time effluent shall finds its way to any water body directly or indirectly.

- (v) Sewage Effluent Treatment: The applicant shall provide comprehensive treatment system as is warranted with reference to influent quality and operate and maintain the same continuously so as to achieve the quality of treated effluent to the following standards.
 - (1)Suspended Solids Not to exceed 100 mg/l. (2)BOD 3 days 270 C. Not to exceed 100 mg/l.
- (vi) Sewage Effluent Disposal: The treated sewage effluent shall be disposed on land for gardening within premises only.

(viii)Other Conditions: Industry should monitor effluent quality regularly.

4. CONDITIONS FOR MOLASSES STORAGE:

The molasses shall be properly collected and stored in steel tanks which shall be absolutely leak proof. At no stage of handling of molasses, there shall be leakage or spillage.

ii) The capacity of tanks for storage of molasses shall be such that at no time the molasses shall be required to be stored in kutcha pits. Adequate space storage capacity shall be available to take care of

bumper production of sugar, non-lifting of molasses etc.

iii) All the area on which molasses are stored and handled should be provided with drain for diverting the spills to the treatment plant/ tank. Suitable arrangements for accidental discharges of molasses from the tanks shall be provided to contain the same within factory premises.

Destruction of molasses and its disposal shall not be done without specific permission in writing from the authorized officer of the Board, intimation of intention to destroy or dispose of the molasses shall be given to the Board at least 15 (fifteen) days in advance by registered post under intimation to the Sub-Regional officer and Regional officer of the Board under whose jurisdiction the factory is situated.

The storage tanks shall be kept in good conditions all the year round with adequate maintenance. The tanks size and capacity per cm, height, total capacity in tones shall be displayed prominently near the tank.

The above conditions shall be in addition to and not in derogation of the provisions contained in the "Bombay Molasses Rules, 1955" and "Maharashtra Molasses Storage and Supply Regulation, 1965"

i) The industry should monitor effluent quality regularly.

5. The applicant shall comply with the provisions of the Water (Prevention & Control of Pollution) Cess Act, 1977 (to be referred as Cess Act) and amendment Rules, 2003 there under

The applicant shall regularly submit to the Board the returns of water consumption in the prescribed form and pay the Cess as specified under Section 3 of the said Act.

6. CONDITIONS UNDER AIR ACT:

(i) The applicant shall install a comprehensive control system consisting of control equipments as is warranted with reference to generation of emission and operate and maintain the same continuously so as to achieve the level of pollutants to the following standards:

a) Control Equipment:

Dust Collector of sufficient capacity shall be provided to all dust generating sections.

(iv) The applicant shall provide ports in the chimney/(s) and facilities such as ladder, platform etc. for monitoring the air emissions and the same shall be open for inspection to/and for use of the Board's Staff. The chimney(s) vents attached to various sources of emission shall be designated by numbers such as S-1, S-2, etc. and these shall be painted/ displayed to facilitate identification.

(v) The industry shall take adequate measures for control of noise levels from its own sources within the premises so as to maintain ambient air quality standard in respect of noise to less than 75 dB(A) during day time and 70 dB(A) during night time. Day time is reckoned in between 6 a.m. and 10 p.m. and night time is reckoned between 10 p.m. and 6 a.m.

(vi) Other Conditions:

1) The industry should not cause any nuisance in surrounding area.

2) The industry should monitor stack emissions and ambient air quality

7. Conditions for D.G. Set

- a. Noise from the D.G. Set should be controlled by providing an acoustic enclosure or by treating the room acoustically.
- b. Industry should provide acoustic enclosure for control of noise. The acoustic enclosure/ acoustic treatment of the room should be designed for minimum 25 dB (A) insertion loss or for meeting the ambient noise standards, whichever is on higher side. A suitable exhaust muffler with insertion loss of 25 dB (A) shall also be provided. The measurement of insertion loss will be done at different points at 0.5 meters from acoustic enclosure/room and then average.
- c. The industry shall take adequate measures for control of noise levels from its own sources within the premises in respect of noise to less than 75 dB(A) during day time and 70dB(A) during the night time. Day time is reckoned between 6 a.m. to 10 pm and night time is reckoned between 10 p.m to 6 a.m.
- d. Industry should make efforts to bring down noise level due to DG set, outside industrial premises, within ambient noise requirements by proper sitting and control measures.
- e. Installation of DG Set must be strictly in compliance with recommendations of DG Set manufactures.
- f. A proper routine and preventive maintenance procedure for DG set should be set and followed in consultation with the DG manufacturer which would help to prevent noise levels of DG set from deteriorating with use
- g. D.G. Set shall be operated only in case of power failure
- h. The applicant should not cause any nuisance in the surrounding area due to operation of D.C. Set.

8. CONDITIONS UNDER HAZARDOUS WASTE (MANAGEMENT, HANDLING & TRANSBOUNDRY MOVEMENT) RULES, 2008:

(i) The Industry shall handle hazardous wastes as specified below.

The authorization is hereby granted to operate a facility for collection, storage, transport & disposal of hazardous waste.

The industry should comply with the Hazardous Waste (M,H & TM) Rules, 2008.

a. Whenever due to any accident or other unforeseen act or even, such emissions occur or is apprehended to occur in excess of standards laid down, such information shall be forthwith Reported to Board, concerned Police Station, office of Directorate of Health Services, Department of Explosives, Inspectorate of Factories and Local Body. In case of failure of pollution control equipments, the production process connected to it shall be stopped.

- b. The unit has to display and maintain the data online outside the factory main gate in Marathi & English both on a 6'x4' display board in the manner and the report of the compliance along with photograph shall be submitted to this office & concerned Regional Office/ Sub Regional Office.
- c. It shall be ensured that the Hazardous waste is handled, managed & disposed of strictly in accordance with the Hazardous Waste (Management & Handling) Rules, 1989 as amended on 2003 and shown & submitted to the Board as & when asked for.

9. Industry shall comply with following additional conditions:

i. The applicant shall maintain good housekeeping and take adequate measures for control of pollution from all sources so as not to cause musance to surrounding area / inhabitants.

ii. The applicant shall bring minimum 33% of the available open land under green coverage/ tree plantation.

iii. Solid waste – The non hazardous solid waste arising in the factory premises, sweepings, etc., be disposed of scientifically so as not to cause any nuisance / pollution. The applicant shall take necessary permissions from civic authorities for disposal to dumping ground.

iv. The applicant shall provide for an alternate electric power source sufficient to operate all pollution control facilities installed by he applicant to maintain compliance with the terms and conditions of the consent. In the absence, the applicant shall stop, reduce or otherwise, control production to abide by terms & conditions of this consent regarding pollution levels.

v. The applicant shall not change or alter quantity, quality, the rate of discharge, temperature or the mode of the effluent / emissions or hazardous wastes or control equipments provided for without previous written permission of the Board.

vi. The applicant shall provide facility for collection of environmental samples and samples of trade and sewage effluents, air emissions and hazardous wastes to the Board staff at the terminal or designated points and shall pay to the Board for the services rendered in this behalf.

vii. The applicant shall make an application for renewal of the consent at least 60 days before the date of the expiry of the consent.

viii. The firm shall submit to this office, the 30th day of September every year, the Environmental Statement Report for the financial year ending 31st March in the prescribed Form-V as pre the provisions of rule 14 of the Environment (Protection) (Second Amendment) Rules 1992

(Protection) (Second Amendment) Rules, 1992. X. As inspection book shall be opened and made available to the Board's officers during their visit to the applicant.

x. The applicant shall install a separate electric meter showing the consumption of energy for operation of domestic and industrial effluent treatment plants and air pollution control system. A register showing consumption of chemicals used for treatment shall be maintained.

Xi. Separate drainage system shall be provided for collection of trade and sewage effluents. Terminal manholes shall be provided at the end of collection system with arrangement for measuring the flow. No effluent shall be admitted in the pipes / sewers down-stream of the terminal manholes. No effluent shall find its way other than in designed and provided collection.

- xii. Neither storm water nor discharge from other premises shall be allowed to mix with the effluents from the factory.
- 10. The Board reserves the right to amend, add/delete/suspend any condition in this consent and same shall be binding on the applicant.
- 11. This consent shall not be construed as any exemption from obtaining necessary No Objection Certificate from other Government agencies as may deemed fit necessary.
- 12. If any Chamber of MIDC is found chocked or pipe line carrying effluent from industry to CETP is breaked/leaked, industry shall stop voluntarily discharge of treated effluent into drainage pipeline provided by MIDC. In such cases the treated effluent shall be stored within premises or to be disposed to CETP by Tankers. Proper manifest system of the same to be maintained and submitted to Sub-Regional Officer/Regional Officer of Board.
- 13.The Bank Guarantee submitted of Rs. 5.0 lakh shall be extended. The validity of bank Guarantee shall be coterminous with consent validity period.
- 14. This Consent is issued pursuant to the decision of consent Committee meeting of Board held on 30.05.2013.
