WHEREWAS, you have made an application for grant of Consent to Establish under Section 25 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and under Rule 5 of the Hazardous Waste (Management, Handling and Tran boundary Movement) Rules, 2008 for construction of the residential project "Mhalunge Riveria" S. No. 39/1, 39/2, 40/1, At-Mhalunge, Tal - Mulshi, Dist-Pune

AND WHEREAS, the application was discussed in the Consent Committee Meeting of the Board dated 15/10/2013 and your project is located **50 meters** from the notified river Mula (A-II Class) which does not fulfill Distance Criteria under the River Regulation Policy, Govt. of Maharashtra dated 13th July 2009 (location of STP 100 meters & MSW 500 meters from HFL), therefore it was decided to issue refusal of consent to establish.

THEREFORE, you are hereby directed to stop construction work at the aforesaid site till further orders.

THEREFORE, your application for grant of Consent to Establish is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981.

You may prefer Appeal against the Refusal Order passed by the Maharashtra Pollution Control Board, in case aggrieved by the refusal order, within a period of 30 days from the date of receipt of the Refusal order.
