
AND WHEREAS, it has been observed that you have started your construction activities without obtaining Consent to Establish from MPC Board & Environment clearance from the Competent Authority and you have also failed to submit reply of the Show Cause Notice & stop work Directions issued by the Board.

AND WHEREAS, Your application for Consent to Establish is discussed before the Consent Appraisal Committee in the meeting held on 04/12/2013 & it has decided to issue refusal of Consent to Establish and stop work directions, for non submission of reply to the Show cause Notice issued by Board on 26/07/2013 & not obtained Consent to Establish from Board & Environment clearance from the Competent Authority.

NOW, THEREFORE, your application for grant of Consent to Establish is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981.
