WHEREAS, Maharashtra Pollution Control Board is in receipt of your application for grant of Consent to Operate (part) for the construction of township project at Vill Jambhe, Marunji, Nere, Tal-Mulshi, Dist- Pune under the provisions of the Water (Prevention and Control of Pollution) Act, 1974, the Air (Prevention and Control of Pollution) Act, 1981 and the Hazardous Wastes (Management, Handling and Transboundary Movement) Rules, 2008 vide ref. no.3.

ANDWHEREAS, Board has issued SCN for refusal vide ref. no. 4 as STP is under construction, EC is not valid and also area details mismatch between C to E, EC.

ANDWHEREAS, Board is in receipt of your letter vide ref. no. 5 wherein you have only requested to correct the total Built-up area in C to E as per EC. Accordingly the case was placed and discussed in the 22nd CAC meeting held on 15.2.2014 alongwith your letter. During the discussion it was decided to refuse the 1st Consent to Operate (part) as EC is not valid and project proponent (PP) has not submitted reply to the SCN in terms of status of STP and revalidation of EC. (Copy of minutes is also available on Board's website).

THEREFORE, your application for grant of Consent to Operate (part) is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and u/s 21 of the Air (Prevention and Control of Pollution) Act, 1981 and the Hazardous Wastes (Management, Handling and Transboundary Movement) Rules, 2008.

You may prefer Appeal against the Refusal Order passed by the Maharashtra Pollution Control Board, in case aggrieved by the refusal order, within a period of 30 days from the date of receipt of the Refusal order to Appellate Authority.
