We refer to application for grant of Consent u/s 25/26 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981 and Hazardous Wastes (Management. Handling and Trans -boundary Movement) Rules 2008.

AND WHEREAS, Board office had issued Proposed direction vide letter dated 14.01.2011 for causing the pollution problem in the vicinity, AND WHEREAS, Board office had issued Interim directions vide letter dtd.27.01.2011. AND WHEREAS you have not complied the directions of the same. AND WHEREAS, you have not replied to the letter which referred at Sr. No. 4 above, nor submitted requisite fees for renewal of consent. AND WHEREAS your application and present status of compliance of pollution control system was discussed in Consent Committee meeting of the Board held on 29/04/2014 and decided to issue final refusal with stop work for consent to operate as industry has failed to submit requisite consent fee.

In view of the aforesaid non compliance, your application for grant of first consent to operate is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.
