If in case due to some genuine problems like periodic cleaning of the system, heavy B] rainfall etc. it become necessary to discharge the effluent of sewer/ land/ stream then the effluent shall conform to the following standards at the final outlet of the coal washery, for that the applicant shall provide comprehensive treatment system consisting of primary / secondary and/or tertiary treatment as is warranted with reference to influent quality and operate and maintain the same continuously so as to achieve the quality of the treated effluent to the following standards :

CONDITIONS UNDER AIR (Prevention and Control of Pollution) ACT, 1981: 5.

The applicant shall install a comprehensive control system consisting of control 1) equipments as is warranted with reference to generation of emission and operate and maintain the same continuously so as to achieve the level of pollutants to the following standards:

Control Equipment: A]

- Coal handling plant shall be provided with Dust Collector, complete dust extraction arrangement and Automatic Water Sprinkler with fog nozzles shall be provided where necessary for dust- suppression. Dust generation points / machinery shall be covered
- Bag filters of sufficient capacity shall be provided to coal crusher, pulverizes & all ii) sources of dust emission and operate it properly.
- Spraying of water through mist sprays and water curtains on all working area, dump iii) area, stock piles.
- Coal shall be properly covered during transportation. iv)
- The applicant shall carry out tree plantation along road side. V)
- All internal roads shall be paved and well maintained to prevent dust emissions. vi)
- Overloading of dumpers shall be avoided to prevent spillages. vii)
- Water or Water mixed chemical shall be sprayed at all strategic coal transfer points VIII) such as conveyors, loading unloading points etc. As far as practically possible conveyors, transfer points etc. shall be provided with enclosures.
- The crushers/ pulverisers of the coal washeries shall be provided with enclosures, ix) fitted with suitable air pollution control measures and finally emitted through a stack of minimum height of 30 m., conforming particulate emission standard of 150 mg/Nm3 or provided with adequate water sprinkling arrangement.
- Water sprinkling by using fine atomizer nozzles arrangement shall be provided on the X) coal heaps and on land around the crushers/ pulverisers.
- Area, in and around the coal washery shall be pucca either asphalted or concreted. xi)
- Green belt shall be developed along the road side, coal handling plants residential XII) complex, office building an all around the boundary line of the coal washery.
- Storage bunkers, hoppers, rubber decks, in chutes and centrifugal chutes shall be XIII) provided with proper rubber linings.
- Vehicles movement in the coal washery area shall be regulated effectively to avoid xiv) traffic congestion. High pressure horn shall be prohibited. Smoke emission form heavy

duty vehicle operating in the coal washeries should confirm the standards prescribed under Motor Vehicle Rules 1989.

The coal transportation shall be done by conveyor system wherever possible or mechanically covered vehicles shall be provided for transportation of coal.

B1 Conditions for D. G. Set:-

Noise from the D. G. Set should be controlled by providing an acoustic enclosure or by

treating the room acoustically.

ii) Industry should provide acoustic enclosure for control of noise. The acoustic enclosure/acoustic treatment of the room should be designed for minimum 25 dB(A) insertion loss or for meeting the ambient noise standards, whichever is on higher side. A suitable exhaust muffler with insertion loss of 25 dB(A) shall also be provided. The measurement of insertion loss will be done at different points at 0.5 metres from acoustic enclosure/room and then average.

iii) The industry shall take adequate measures for control of noise levels from its own sources within the premises in respect of noise to less than 55 dB(A) during day time and 45 dB(A) during the night time. Day time is reckoned between 6 a.m. to 10

p. m and night time is reckoned between 10 p. m to 6 a.m.

iv) Industry should make efforts to bring down noise level due to DG set, outside industrial premises, within ambient noise requirements by proper siting and control measures.

v) Installation of DG Set much be strictly in compliance with recommendations of DG Set

manufacturer.

vi) A proper routine and preventive maintenance procedure for DG set should be set and followed in consultation with the DG manufacturer which would help to prevent noise levels of DG set from deteriorating with use.

vii) D. G. Set shall be operated only in case of power failure.

viii) The applicant should not cause any nuisance in the surrounding area due to operation of D.G. Set.

C] Fugitive emission standards:

The difference in the value of suspended particulate matter, delta (D), and measured between 25 and 30 meter from the enclosure of coal crushing plant in the downward and leeward wind direction shall not exceed 150 microgram per cubic meter.

D] Standards for Stack Emissions:-

(i) TPM Not to exceed 150 mg/Nm³ (ii) SO₂ Not to exceed 5.0 Kg/Day.

El Standards for Ambient Air Pollutants:

F] Noise level standard:

Operation/ Working zone-not to exceed 85 dB(A) Leq for 8 hours exposure.

The ambient air quality standards in respect of noise as notified under Environmental (Protection) Rules, 1986 shall be followed at the boundary line of the coal washery.

- The applicant shall install a continuous automatic ambient air and micrometeorological monitoring station at location indicated by State Board to be set up and operate at its own cost measure SO₂, NO_x and particulate matter. These CAAQMS shall also have necessary provision of networking to the Air Quality Monitoring network of MPCB website http://mpcb.gov.in as well as to the respective Regional Office.
- V) The applicant shall take adequate measures for control of noise levels from its own sources as follows:

VI) Other Conditions: --

- Whenever due to any accident or other unforeseen act or even, such emissions occur or is apprehended to occur in excess of standards laid down, such information shall be forthwith Reported to Board, concerned Police Station, office of Directorate of Health Services, Department of Explosives, Inspectorate of Factories and Local Body. In case of failure of pollution control equipments, the production process connected to it shall be stopped.
- (ii) Coal Washeries shall follow the conditions of the Ministry of Environment & Forests, Government of India's Notification No.Q.15017/13/95-CPW, dated 27th January, 1999 strictly.
- CONDITIONS UNDER HW (M, H & T) RULES, 2008: The industry shall not generate any hazardous waste.
- 7. The applicant shall comply with the conditions of Environmental Clearance granted by MoEF, GOI.
- 8. General conditions:
- (i) The applicant shall bring minimum 33% of the available open land under green coverage/ plantation. The applicant shall submit a yearly statement by 30th September every year on available open plot area, no. of trees surviving as on 31st March of the year and no. of trees planted by September end.
- (ii) The applicant shall provide for an alternate electric power source sufficient to operate all pollution control facilities installed by he applicant and operate the same in case of power failure to maintain compliance with the terms and conditions of the consent. In the absence of same, the applicant shall stop, reduce or otherwise, control production to abide by terms & conditions of this consent regarding pollution levels.
- (iii) The applicant shall make an application for renewal of the consent at least 60 days before the date of the expiry of the consent. The applicant shall not change or alter quantity, quality, the rate of discharge, temperature or the mode of the effluent/ emissions or hazardous wastes or control equipments provided for without previous written permission of the Board.
- (iv) The firm shall submit MPCB, the Environmental Statement Report for the financial year ending 31st March in the prescribed Form-V as pre the provisions of rule 14 of the Environment (Protection) (Second Amendment) Rules, 1992 before 30th September every year.
- (v) The applicant shall install a separate meter showing the consumption of energy for operation of domestic and industrial effluent treatment plants and air pollution control system. A register showing consumption of chemicals used for treatment shall be maintained. The applicant shall also submit a comparative statement of designed power and chemical consumptions vis-a vis actual power and chemical consumption along with Environmental statement.
- (vi) Separate drainage system shall be provided for collection of trade and sewage effluents. Terminal manholes shall be provided at the end of collection system with arrangement for measuring the flow. No effluent shall be admitted in the pipes/sewers down- stream of the terminal manholes. No effluent shall find its way other than in

designed and provided collection system. Neither storm water nor discharge from other premises shall be allowed to mix with the effluents from the factory.

The applicant shall provide facility for collection of environmental samples and (vii) samples of trade and sewage effluents, air emissions and hazardous wastes to the Board staff at the terminal or designated points and shall pay to the Board for the services rendered in this behalf. An inspection book shall be opened and made available to the Board's officers during their visit to the applicant.

The industry shall ensure that fugitive emissions from the activity are controlled so as (viii)

to maintain clean and safe environment in and around the factory premises.

- The Industry shall maintain a daily record of raw material received, finished product 9. sent and material stored in premises, which shall be made available to MPCB officials.
- The material transportation shall not cause any nuisance. 10.
- This Board reserves the right to amend or add any conditions in this consent and the 11. same shall be binding on the Applicant.
- The applicant shall comply the directions issued by Board vide no.MPCB/APAE/Dir-12. 15/TB-1/B-6821 dated 27.10.2010 and the directions issued by Board time to time.
- The applicant shall implement mechanical close type transportation system for 13. coal & mineral metal transporting trucks.
- The applicant shall extend the existing BG of Rs.1.5 Lac and Rs.3.5 Lacs up to 14. consent validity period i.e up to 31.7.2015 and submit the extended BG to RO MPCB Chandrapur within 15 days.
