

This office is in receipt of your aforesaid application to Board for grant of renewal of authorization for Reception, collection and transportation of Hazardous waste under Schedule I & II form various industrial unit located in Maharashtra to registered recycling/ re-refining industry having valid registration from CPCB and valid consent/ authorization from MPCB or to CHWTSDf or CETP's.

The Board hereby authorize you for collection, reception and transportation of hazardous wastes as mentioned in Schedule I & II form various industrial unit located in Maharashtra to registered recycling / re-refining industry having valid registration from CPCB and valid consent/ authorization from MPCB or to CHWTSDf or CETP's under Hazardous Waste (Management, Handling & Transboundry Movement) Rules, 2008. You shall transport hazardous wastes through vehicles bearing **No: MH-04/CP-9751 & MH-04/DD-6418** authorized by MPCB, under the rules subject to the following terms and conditions:-

1. The Authorization shall be in force for a period of **One Year** i.e. upto **31/10/2015** however the Board can revoke the same if the performance of the applicant is found unsatisfactory and not as per the conditions of this authorization.
2. The Authorization is valid within the state of Maharashtra only.
3. **You shall follow manifest system as per Rule 21(1). You shall maintain all the necessary records & submit it to this office along with copy to concerned Regional Office / Sub Regional Office. You shall also submit form-4 of the Rules.**
4. **The transporter shall strictly follow the provisions under the Motor Vehicles Act,1988 and rules made there under.**
5. You shall install 'Global positioning system' (GPS) to your Hazardous Waste transporting vehicle and accordingly inform to this office.
6. The applicant shall comply with conditions as stipulated under **Annexure-I** enclosed.
