- 7. The Board reserves the right to review, amend, suspend, revoke etc. this consent and the same shall be binding on the industry.
- 8. The industry shall comply with the guidelines on rendering plant published by Central Pollution Control Board.
- 9. The industry should not cause any smell nuisance in surrounding area. If problem of smell nuisance created, industry shall voluntarily stop the production activity.
- 10. Industry shall provide air tight container vehicles for collection and transpiration of bone.
- 11. Industry shall provide closed shed for bone crushing activity with dust collection & air ducting arrangement with suitable height.
- 12. Industry shall provide rendering plant for extraction of tallow oil.
- 13. Industry shall provide biological scrubber to rendering plant for de-odorization.
- 14. Industry shall provide closed shed for storage of bones & for mitigation of smell nuisance, smell suppress powder/deodorant will be sprayed.
- 15. Industry shall plant various species of scent flowers along the periphery of the industry so as to minimize the smell nuisance.
- 16. This consent is granted subject to industry shall obtain permanent No Objection Certificate from Solapur Municipal Corporation at the time of actual start of production activity.

- 1) A] As per your application, you have provided the Effluent Treatment Plant (ETP) with the design capacity of 0.50 CMD.
 - B] The Applicant shall operate the effluent treatment plant (ETP) to treat the trade effluent so as to achieve the following standards prescribed by the Board or under EP Act, 1986 and Rules made there under from time to time, whichever is stringent.

- 2) A.] As per your consent application, you have provided the sewage treatment system with the design capacity of 0.30 GMD.
 - B] The Applicant shall operate the sewage treatment system to treat the sewage so as to achieve the following standards/ prescribed under EP Act, 1986 and Rules made there under from time to time, whichever is stringent.

- 1) The applicant shall provide facility for collection of environmental samples and samples of trade and sewage effluents, air emissions and hazardous waste to the Board staff at the terminal or designated points and shall pay to the Board for the services rendered in this behalf.
- 2) Industry should monitor effluent quality, stack emissions and ambient air quality monthly/quarterly.
- 3) The applicant shall provide ports in the chimney/(s) and facilities such as ladder, platform etc. for monitoring the air emissions and the same shall be open for inspection to/and for use of the Board's Staff. The chimney(s) vents attached to various sources of emission shall be designated by numbers such as S-1, S-2, etc. and these shall be painted/displayed to facilitate identification.
- 4) Whenever due to any accident or other unforeseen act or even, such emissions occur or is apprehended to occur in excess of standards laid down, such information shall be forthwith Reported to Board, concerned Police Station, office of Directorate of Health Services, Department of Explosives, Inspectorate of Factories and Local Body. In case of failure of pollution control equipments, the production process connected to it shall be stopped.
- 5) The applicant shall provide an alternate electric power source sufficient to operate all pollution control facilities installed to maintain compliance with the terms and conditions of the consent. In the absence, the applicant shall stop, reduce or otherwise, control production to abide by terms and conditions of this consent.
- 6) The firm shall submit to this office, the 30th day of September every year, the Environmental Statement Report for the financial year ending 31st March in the prescribed Form-V as per the provisions of rule 14 of the Environment (Protection) (Second Amendment) Rules, 1992.
- 7) processed/reused/recovered and only waste which has to be incinerated shall go to incineration and waste which can be used for land filling and cannot be recycled/reprocessed etc should go for that purpose, in order to reduce load on incineration and landfill site/environment.
- 8) An inspection book shall be opened and made available to the Board's officers during their visit to the applicant.
- 9) The applicant shall make an application for renewal of the consent at least 60 days before the date of the expiry of the consent (in case of Renewal of consent).
- 10) Industry shall strictly comply with the Water (P&CP) Act, 1974, Air (P&CP) Act, 1981 and Environmental Protection Act, 1986 and industry specific standard under EP Rules 1986 which are available on MPCB website(www.mpcb.gov.in).
- 11) The industry shall constitute an Environmental cell with qualified staff/personnel/agency to see the day to day compliance of consent condition towards Environment Protection.
- 12) Separate drainage system shall be provided for collection of trade and sewage effluents. Terminal manholes shall be provided at the end of the collection system with arrangement for measuring the flow. No effluent shall be admitted in the pipes/sewers downstream of the terminal manholes. No effluent shall find its way other than in designed and provided collection system.
- 13) Neither storm water nor discharge from other premises shall be allowed to mix with the effluents from the factory.
- 14) The applicant shall install a separate meter showing the consumption of energy for operation of domestic and industrial effluent treatment plants and air pollution control system. A register showing consumption of chemicals used for treatment shall be maintained.
