General Conditions:

The applicant shall comply with the conditions of Environmental Clearance accorded by MoEF, 1) GOI vide F. No. J-11011/166/2011-IA-II (I), dated 21.11.2013 2)

The applicant shall provide facility for collection of environmental samples and samples of trade and sewage effluents, air emissions and hazardous waste to the Board staff at the terminal or designated points and shall pay to the Board for the services rendered in this behalf. 3)

The industry should monitor effulent quality , stack emissions and ambient air quality 4)

- The applicant shall provide ports in the chimney/(s) and facilities such as ladder, platform etc. for monitoring the air emissions and the same shall be open for inspection to/and for use of the Board's Staff. The chimney(s) vents attached to various sources of emission shall be designated by numbers such as S-1, S-2, etc. and these shall be painted/ displayed to facilitate identification.
- Whenever due to any accident or other unforeseen act or even, such emissions occur or is 5) apprehended to occur in excess of standards laid down, such information shall be forthwith Reported to Board, concerned Police Station, office of Directorate of Health Services, Department of Explosives, Inspectorate of Factories and Local Body. In case of failure of pollution control equipments, the production process connected to it shall be stopped. 6)

The applicant shall provide an alternate electric power source sufficient to operate all pollution control facilities installed to maintain compliance with the terms and conditions of the consent. In the absence, the applicant shall stop, reduce or otherwise, control production to abide by terms and conditions of this consent.

The firm shall submit to this office, the 30th day of September every year , the Environmental 7) Statement Report for the financial year ending 31st March in the prescribed Form-V as per the provisions of rule 14 of the Environment (Protection) (Second Amendment) Rules, 1992. 8)

An inspection book shall be opened and made available to the Board's officers during their visit

The applicant shall make an application for renewal of the consent at least 60 days before the 9) date of the expiry of the consent.

- Industry shall strictly comply with the Water (P&CP) Act, 1974, Air (P&CP) Act, 1981 and 10) Environmental Protection Act,1986 and industry specific standard under EP Rules 1986 which are available on MPCB website(www.mpcb.gov.in). 11)
- The industry should comply with the Hazardous Waste (M,H & TM) Rules, 2008 and submit the Annual Returns as per Rule 5(6) & 22(2) of Hazarsous Waste (M,H & TM) Rules, 2008 for the preceding year April to March in Form-IV by 30th June of every year. The industry

- Separate drainage system shall be provided for collection of trade and sewage effluents. Terminal manholes shall be provided at the end of the collection system with arrangement for measuring the flow. No effluent shall be admitted in the pipes/sewers downstream of the terminal manholes. No effluent shall find its way other than in designed and provided collection system.

The applicant shall install a separate meter showing the consumption of energy for operation of 15) domestic and industrial effluent treatment plants and air pollution control system. A register showing consumption of chemicals used for treatment shall be maintained. 16) Conditions for D.G. Set

Noise from the D.G. Set should be controlled by providing an acoustic enclosure or by treating the a)

Industry should provide acoustic enclosure for control of noise. The acoustic enclosure/ acoustic b) treatment of the room should be designed for minimum 25 dB (A) insertion loss or for meeting the ambient noise standards, whichever is on higher side. A suitable exhaust muffler with insertion loss of 25 dB (A) shall also be provided. The measurement of insertion loss will be done at different points at 0.5 meters from acoustic enclosure/room and then average.

- Industry should make efforts to bring down noise level due to DG set, outside industrial c) premises, within ambient noise requirements by proper sitting and control measures. d)
- Installation of DG Set must be strictly in compliance with recommendations of DG Set

- The applicant shall maintain good housekeeping.
- 20) The applicant shall bring minimum 33% of the available open land under green coverage/ plantation. The applicant shall submit a statement on available open plot area, number of trees surviving as on 31st March of the year and number of trees planted by September end. 21)
- The non-hazardous solid waste arising in the factory premises, sweepings, etc. be disposed of scientifically so as not to cause any nuisance / pollution. The applicant shall take necessary permissions from civic authorities for disposal of solid waste.
- The applicant shall not change or alter the quantity, quality, the rate of discharge, temperature or 22) the mode of the effluent/emissions or hazardous wastes or control equipments provided for without previous written permission of the Board.
