We refer to application for grant of Consent u/s 25 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981 and Hazardous Wastes (Management, Handling and Trans -boundary Movement) Rules 2008.

AND WHEREAS, Board office had issued Show Cause Notice vide letter dated 21.08.2015 as serious complaints made regarding poor performance and inadequate capacity of CETP-TEPS, as existing CETP is having capacity of 25 MLD but not having capacity to collect, treat and dispose excess effluent of 20-25 MLD.

AND WHEREAS your application along with your reply referred at Sr. No. 3 was discussed in Consent Committee meeting of the Board held on 03.02.2016 and decided to issue refusal of consent to establish for expansion as the associated TEPS CETP is not complying with the required standards and the CETP do not have adequate hydraulic load capacity.

AND WHEREAS Maharashtra Pollution Control Board has issued Circular dated. 21.09.2016 in compliance with the orders issued by Hon'ble National Green Tribunal and Hon'ble High Court for not to consider expansion/ establishment of industrial units in the area of the non conforming CETPs.

In view of the aforesaid, your application for grant of consent to establish for expansion is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.
