B] The Applicant shall operate the effluent treatment plant (ETP) to treat the Trade effluent so as to achieve the following standards prescribed by the Board or under EP Act, 1986 and Rules made there under from time to time,

In case of failure of pollution control equipments, the production process connected to it shall be stopped.

The applicant shall provide an alternate electric power source sufficient to operate all 6) pollution control facilities installed to maintain compliance with the terms and conditions of the consent. In the absence, the applicant shall stop, reduce or otherwise, control

production to abide by terms and conditions of this consent.

The industry shall submit official e-mail address and any change will be duly informed to 26)

the MPCB.

The industry shall achieve the National Ambient Air Quality standards prescribed vide 27) Government of India, Notification dt. 16.11.2009 as amended.
