WHEREAS Board has granted Consent to Operate to your unit vide above referred letter at sr. no. 1 with certain terms and conditions therein which was valid up to 31.08.2014.

AND WHEREAS you have applied for grant of Renewal of Consent to Operate, under the provisions of Section 26 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundry Movement) Rules 2008.

AND WHEREAS, your application for grant of Renewal of Consent to Operate was placed before CAC meeting held on 14.05.2015 and during meeting it was decided to

issue Show Cause Notice for refusal of Renewal of Consent to Operate due to following non-compliance/ violations –

- You have not submitted the BG for O & M of pollution control system, imposed in previous consent.
- You have not provided final disposal arrangements for the disposal of spent wash.
- You have not complied with the CREP guidelines.
- 4. You were discharged the spent wash in to the natural pond.

AND WHEREAS, as per the decision of CAC, Show Cause Notice was issued vide dtd. 25.05.2015.

AND WHEREAS, you have failed to submit reply to the Show Cause Notice issued by the Board.

AND WHEREAS your application was again placed before Consent Appraisal Committee meeting held on 25.01.2016, during meeting it was noted that Board had issued Show Cause Notice for Refusal of Renewal of Consent to Operate on 25.05.2015, it was also noted that industry has not replied to the Show Cause Notice nor complied the conditions of previous Consent to Operate. Hence it was decided to confirm the final Refusal of Consent to Operate.

In view of the above, your application for grant of Renewal of Consent to Operate is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008.

You may prefer Appeal against the refusal order passed by Maharashtra Pollution Control Board, in case aggrieved by this order, to Appellate Authority within a period of 30 days from the date of receipt of the Refused order.
