- Whenever due to any accident or other unforeseen act or even, such emissions occur or is 5) apprehended to occur in excess of standards laid down, such information shall be forthwith Reported to Board, concerned Police Station, office of Directorate of Health Services, Department of Explosives, Inspectorate of Factories and Local Body. In case of failure of pollution control equipments, the production process connected to it shall be 6)
- The applicant shall provide an alternate electric power source sufficient to operate all pollution control facilities installed to maintain compliance with the terms and conditions of the consent. In the absence, the applicant shall stop, reduce or otherwise, control production to abide by terms and conditions of this consent.
- The firm shall submit to this office, the 30th day of September every year, the 7) Environmental Statement Report for the financial year ending 31st March in the prescribed Form-V as per the provisions of rule 14 of the Environment (Protection) 8)

Noise from the D.G. Set should be controlled by providing an acoustic enclosure or by a)

- Industry should provide acoustic enclosure for control of noise. The acoustic enclosure/ b) acoustic treatment of the room should be designed for minimum 25 dB (A) insertion loss or for meeting the ambient noise standards, whichever is on higher side. A suitable exhaust muffler with insertion loss of 25 dB (A) shall also be provided. measurement of insertion loss will be done at different points at 0.5 meters from acoustic c)
- Industry should make efforts to bring down noise level due to DG set, outside industrial premises, within ambient noise requirements by proper sitting and control measures.
