AND WHEREAS, Board office had issued Show Cause Notice vide letter MPCB/JD (WPC)/NK/SCN/B-938, Dtd. 12/03/2015 as, Your unit is not complying with CREP norms.

AND WHEREAS your application and proposal submitted by RO-Nagpur was discussed in Consent Committee meeting of the Board held on 03.02.2016 and decided to issue final refusal of consent to operate and stop work for below mentioned non-compliances.

- Industry has not provided ESP/We Scrubber to Boiler as per CREP norms to C to E.
- Not provided continuous monitoring system and electromagnetic flow meter with data logger.

In view of the aforesaid non compliance, your application for grant of consent is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.
