WHEREAS Board has granted Consent to Operate to your existing unit vide above referred letter at sr. no. 1 with certain terms and conditions therein which is valid up to 30.04.2017.

AND WHEREAS you have applied for grant of Consent to Establish for expansion, under the provisions of Section 25 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundry Movement) Rules 2008.

AND WHEREAS, your application for grant of Consent to Establish for expansion was placed before CAC meeting held on 17.12.2015 and during meeting it was decided to issue SCN for Refusal of Consent to Establish for expansion due to following non-compliances / violations—

- JVS results of the trade effluent collected on 28.01.2014, 14.03.2014, 28.11.2014 & 01.04.2015 are exceeding the Consented limits. Also results of the sewage collected on 06.02.2014, 07.05.2014, 27.06.2014 & 27.08.2014 are exceeding the Consented limits.
- 2. You have provided total 13.5 acres of land for disposal of trade effluent and domestic effluent is inadequate as total trade effluent generation including existing & expansion will be 360 CMD & trade sewage 70 CMD. As per thumb rule total 21.5 acres land required for the disposal of trade effluent and domestic effluent.

AND WHEREAS, as per the decision of CAC meeting, Show Cause Notice was issued vide dtd. 28.01.2016 to your unit.

AND WHEREAS, you have failed to submit the reply to the Show Cause Notice issued by the Board.

AND WHEREAS your application was again placed before Consent Appraisal Committee meeting held on 27.04.2016, during meeting it was noted that Board had issued Show Cause Notice for Refusal of Consent to Establish for expansion on 28.01.2016, it was also noted that you have not submitted any reply to the Show Cause Notice for Refusal of Consent to Establish for expansion. Hence it was decided to issue final Refusal of Consent to Establish for expansion.

In view of the above, your application for grant of Consent to Establish for expansion is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008.

You may prefer Appeal against the refusal order passed by Maharashtra Pollution Control Board, in case aggrieved by this order, to Appellate Authority within a period of 30 days from the date of receipt of the Refused order.
