We refer to application for grant of Consent to Establish for expansion of Sugar unit from 2500 TCD to 3500 TCD u/s 25 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981 and Hazardous & Other Waste (Management. and Transboundary Movement) Rules, 2016.

AND WHEREAS, Board had issued Show Cause Notice vide letter dated 08.12.2015, as a) JVS analysis results of existing unit are exceeding the consented limits, b) you have not upgraded the ETP, c) you have not provided and proposed the APC system as per CREP norms.

AND WHEREAS, you have submitted your reply vide letter referred at Sr. No. 3 above which is unsatisfactory. AND WHEREAS your application was re-discussed in Consent Committee meeting of the Board held on 16.06.2016 along with your reply to SCN and decided to issue final refusal of consent to Establish for Expansion as you have failed

to provide the online monitoring system as per the Directions issued by Central Pollution Control Board and JVS reports are not meeting to the consented standards.

In view of the aforesaid non compliance, your application for grant of consent to Establish for expansion is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.
